### **FACT SHEET**

**ENTRY FEE:** \$60 per 2-day tournament. **DEADLINE:** The day before the start of each tournament 4pm.

**REGISTRATION:** Online registration if available at <http://www.mcssl.com/store/caselytennis>. You may register onsite the day before the start of each tournament from 12pm-4pm at the main site of the tournament for players that want to register in person.

**WARM-UP COURTS:** Courts are available for warm-up daily 1 hour before start of matches. Once play begins there are no warm-up courts available.

**OFFICIAL BALL:** Wilson U.S. Open

**DRAW SIZES:** Junior/Open Divisions: 16 player draws

**CONSOLATION:** There is a mandatory sign-in on the second day of each tournament for players that lose their first match and want to play consolation. Matches are one set to 6 games and matches may be on hard court or clay court. Consolation winners in each draw will receive an engraved medal. Players must sign-in in person, no coaches, no parents. Mandatory Sign-In times for Consolation are posted for each tournament on our DRAWS page and at the tournament.

**UTR:** There are UTR points for all matches played.

**RAIN DELAY:** In case of rain delay match format for all divisions may be modified for unstarted matches to short sets to 4 games, No Ad scoring until the tournament is back on schedule.

**LATE ARRIVAL:** We have a 30 minute grace period since players are new to the area and are back and forth between Eddie Herr, Orange Bowl, Casely International. After 15 minutes players will start down 3-0 and loss of toss and defaulted after 30 minutes.

**CONCESSION STAND:** Cafeteria will be in operation from 1 hour before start of matches till 10pm daily
