Message Frequency:

Message frequency may vary depending on the type of communication.

Example:

You may receive up to 2 SMS messages per week regarding your appointments or account status.

Potential Fees for SMS Messaging

Standard message and data rates may apply depending on the recipient's carrier plan. Fees may differ for domestic or international messages.
